Re: Practical Recommendations For Private Healthcare Providers To Prepare for
Contact with Immigration and Customs Enforcement Agents

With the recent increase in visible immigration activity by Immigration and Customs Enforcement (“ICE”) agents, employers and service providers who interact with affected communities should put in place procedures on how to respond to the presence of ICE agents within their premises and how to respond to requests by ICE for information regarding patients. Once these procedures are put in place, it is imperative that every employee becomes familiar with them. This memorandum provides guidance to healthcare providers seeking to establish a policy on how to prepare for and respond to contact with ICE agents within their premises and will provide helpful resources that healthcare providers can share with their patients and visitors.

The cornerstone protection available to all individuals, regardless of immigration status, who are not at an international border, is the 4th amendment, which protects individuals against unreasonable searches and seizures. The reasonableness of a search or seizure turns on several factors, but one of the most important is whether the individual being searched has a reasonable expectation of privacy, with the expectation being at its highest when the information sought or the area to be searched is private.

In the context of private healthcare providers, the issues that are likely to arise are the presence of ICE agents on their premises either to effectuate an arrest or to seek information regarding an individual, or ICE agents waiting outside the premises of healthcare providers also to either arrest an individual or to obtain immigration status information.

STEPS TO TAKE IN ANTICIPATION OF AN ICE AGENT'S VISIT

1. Designate areas that are open to the public and those that are private and train all employees on these distinctions:
 - a. **Public** areas are open to all, including patients, healthcare providers, and members of the public. Examples include reception or lobby areas. These are areas in which there is no expectation of privacy and therefore where ICE agents can enter.
 - i. Do not place any sensitive information in public areas in plain view of the public. Any information displayed in plain view, for example, on a desk, on a bulletin or an electronic board can be used by ICE agents
 - ii. If any information must be maintained in these areas, care should be taken to place them in files or drawers
 - b. **Private** areas should be reserved solely for patients, family members, and the necessary healthcare providers. Ideally such areas should be physically separated from public areas. Since a reasonable person would have expectation of privacy in these areas, ICE agents should not be allowed to enter these areas without a warrant. Examples of such areas include examination room and in some cases waiting rooms, if only authorized personnel have access to these areas.
2. If possible, avoid asking patients for information regarding country of birth, citizenship, or immigration status and maintaining such information in the patient's records if this information is not necessary for the provision of medical services.
3. Designate a staff member who is authorized to speak to an ICE agent on behalf of the healthcare provider. Inform all other employees not to provide any information to ICE agents or to give them access to any area beyond the reception area and to immediately direct all inquiries to the designated staff member.

IF AN ICE AGENT VISITS YOUR PREMISES

1. The receptionist or person at the front desk should contact the designated staff member.
2. The designated staff member should take the following steps:
 - a. Ask the officer to identify themselves (local police or immigration?)
 - b. Write down the full name of the officer(s) present
 - c. Ask why he/she is there and request to see a warrant. If the officer lacks a warrant, respectfully ask that the officer leave your premises. **DO NOT CONSENT TO A SEARCH OF THE PREMISES**
 - d. If the officer provides a warrant, your designated staff member should ensure that the warrant
 - i. Is signed by a judge or a magistrate judge
 - ii. Lists either the name of the person being sought *and* your center's address, or lists medical records as part of the search
 - iii. Is being executed during the time specified in the warrant.

3. If the officer has a valid warrant, private areas may be searched. The designated staff member should contact an immigration attorney immediately so he/she may be present during the search.
4. Ensure that the designated staff member understands that most patient information is protected by federal laws, listed below, and does not need to be disclosed to an ICE agent *unless* the officer provides a valid warrant or court order that specifically requests those records:
 - a. **Protections afforded by the Health Insurance Portability and Accountability Act ("HIPA")** Generally protects against the disclosure of protected health information¹, including a patient's address and social security number, without the patient's consent, except when required by law
 - b. Although evidence of foreign birth is not considered protected health information, federal regulations include protections against the disclosure of **any** information that could uniquely identify an individual
 - c. If an ICE agent requests information on a specific individual, the protections listed above apply, **unless** the request is pursuant to a valid warrant or court order specifically identifying the individual.
5. Inform all present, including patients, that members of your staff will interact with the agent(s) and that members of the public have the right to remain silent.

CREATE A SAFE SPACE FOR PATIENTS

1. If possible, avoid asking patients for countries of birth, social security numbers, or immigration status. If this information is required, explain why it is required, and assure patients that the information they provide is confidential.
2. Have know your rights materials (samples attached) available in your reception or waiting areas.
3. Remind patients that their right to remain silent extends to areas beyond the premises of the health center.

¹ All individually identifiable health information held or transmitted by a covered entity or its business associate.

- **Stay calmed** and don't run.
- **Don't share** your personal or loved one's information (name, address)
- **Don't take ICE to your house** to pick up your ID.

- **ICE Lies:** Do not agree to what ICE asks, for example, do not follow them to their office, to immigration offices or do not agree to meet them for coffee.

- If immigration agents enter your home without your permission, verbally **express that you do not give them permission** to enter your home or search your belongings. Ask for a search and arrest warrant.

• **Do not answer any questions**, exercise your right to remain silent. If you do choose to answer questions, remember to not lie.

• **Do not sign** any documents.

• Ask to speak with your lawyer or a loved one.

• If you feel safe, **record the event** with your cell phone either through video or audio only.

• **ICE Lies:** Do not agree to what ICE asks, for example, do not follow them to their office, to immigration offices like USCIS or do not agree to meet them for coffee.
